

Minutes of the 1966 Business Meeting of the Southern Section  
 AMERICAN SOCIETY OF ANIMAL SCIENCE  
 King Edward Hotel, Jackson, Mississippi  
 February 8, 1966

President Sewell opened the meeting at 4:15 P.M., asking the pleasure of the group concerning the reading of the minutes of the 1965 meeting. Paul B. Brown moved that the 1965 minutes not be read but accepted as recorded. C. J. Brown seconded the motion. Motion carried.

The financial standing of the section was presented by G. L. Robertson. A copy of the final report is attached.

The president called for a report of the Nominating Committee which was composed of C. B. Ammerman, Chairman, G. E. Mitchell and C. B. Ramsey. The following officers were nominated for 1966-67.

Dr. Paul B. Brown moved that nominations be closed and the above officers be elected by acclamation. Several seconded - Motion carried.

W. C. McCormick gave the report of the Resolutions Committee. A copy of the report is attached.

The Chairman made the following announcements.

1. Date of 1967 meeting in New Orleans, Jan. 31 - Feb. 1
2. 1968 Southern Section meeting will be in Louisville, KY.
3. 1966 National meeting will be at Rutgers University, Aug. 1-4.

The president opened the floor for discussion of plans for handling the increasing number of papers, listing the following alternatives:

1. Read some papers by title
2. Schedule night sessions
3. Schedule additional sessions

The consensus of the group was to definitely stay away from night sessions, and seemed to favor limiting the number of papers to about the number that can go into a single session on the first day and two concurrent sessions on the second day and the third morning (as is now the case).

The president pointed out to the group the desirability of presenting all awards competition papers on the same day - in the same session - all in the first afternoon if possible. If the number of such papers gets too great it may be necessary to schedule some of them the first morning.

The president expressed appreciation to the other officers for their cooperation and adjourned the meeting at 4:40 P.M.
